Other than BNYM in respect of 40,800,056 securities (of which BNYM's power to only dispose of 40,800,056 securities is limited – see Note 1), none of the BNYMC Group entities are entitled to be registered as holder of the securities and their power to vote or dispose of the securities is qualified accordingly.
